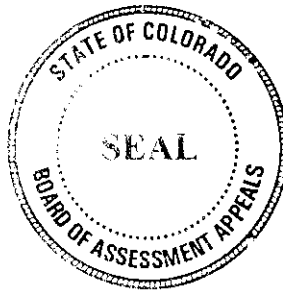

6. The amount to be refunded to the taxpayer is \$659.37.


7. Brief narrative as to why the reduction was made:

The valuations, as established above, shall be binding only with respect to the tax year 2005.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 26, 2008 at 8:30 AM be vacated.
