
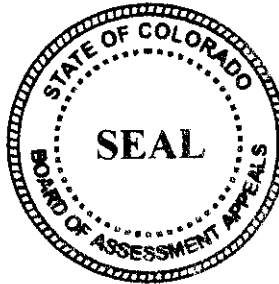

7. Brief narrative as to why the reduction was made:


The deferred maintenance and excess vacancy were recognized in the income approach.
