

6. Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.

- 7. This valuation is for purposes of settlement only and does not reflect an appraised value.
- 8. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the above schedule numbers for the assessment years(s) covered by this Stipulation.
