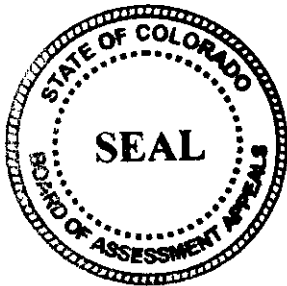

2. The subject property is classified as multi-residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2005.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2005.

6. The valuations, as established above, shall be binding only with respect to tax year 2005.

7. Brief narrative as to why the reduction was made:

The value reduction is based on new market sales data and the recognition of the subject's age/disability restricted rental agreement with the HUD.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on September 13, 2007 at 2:00pm be vacated.
