5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2006 for the subject property:




6. The valuation, as established above, shall be binding only with respect to tax year 2006.


7. Brief narrative as to why the reduction was made: Reduction to income value.
