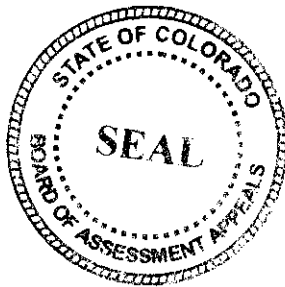



8. Both parties agree that the hearing, as yet unscheduled before the Board of Assessment Appeals, be vacated.


