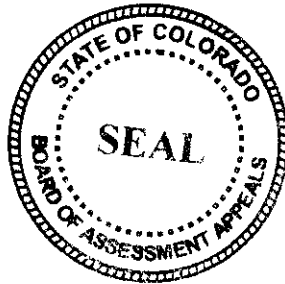

The value was adjusted based on actual income.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 11, 2008 at 1:00pm be vacated.
