6. The valuation, as established above, shall be binding only with respect to tax year 2005 and 2006.


7. Brief narrative as to why the reduction was made: Reduction to income value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 18, 2007, 8:30 a.m., be vacated.


