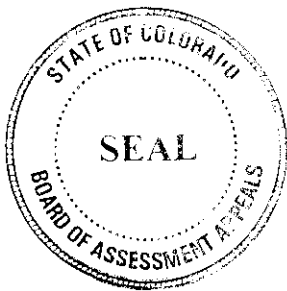

A brief narrative as to why the reduction was made: Analyzed cost, market, & income information.




The valuation, as established above, shall be binding only with respect to the tax year 2006.

Both parties agree that the hearing before the Board of Assessment Appeals be vacated or is unnecessary if one has not yet been scheduled.


