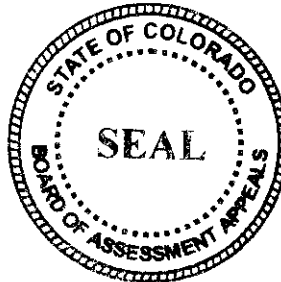

A brief narrative as to why the reduction was made: Analyzed cost, market, & income information.




