1. The property subject to this Stipulation is described as:

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2006:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Total	\$3,700,000


6. The valuations, as established above, shall be binding only with respect to tax year 2006.


7. Brief narrative as to why the reduction was made:
