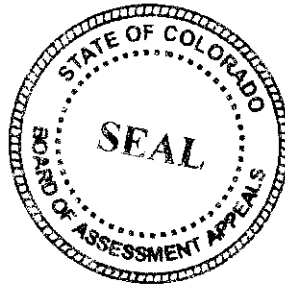

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization increased the value as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2006.

Total	\$	2,618,900.00

6. The valuations, as established above, shall be binding only with respect to tax year 2006.

7. Brief narrative as to why the reduction was made:

Re-equalize the valuations between 2005 & 2006.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 7, 2008 at 8:30am be vacated.
