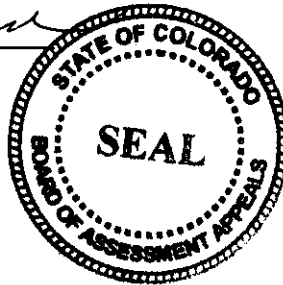

1. The property subject to this Stipulation is described as:

2. The subject property is classified as Commercial property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2006:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2006 for the subject property:


Land	\$	591,765

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on January 17, 2007, at 1:00 p.m. be vacated.


