Respondent is ordered to reduce the 2006 actual value of the subject property, as set forth above.





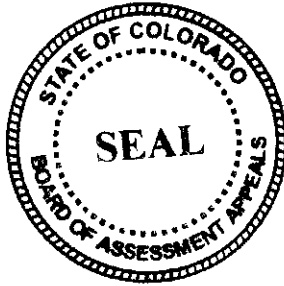

The actual income indicated adjustment was supported.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 18, 2007 at 3:00pm be vacated.
