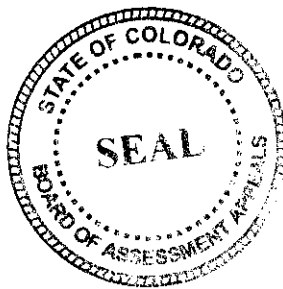

A brief narrative as to why the reduction was made: Analyzed Cost, and Market Information.

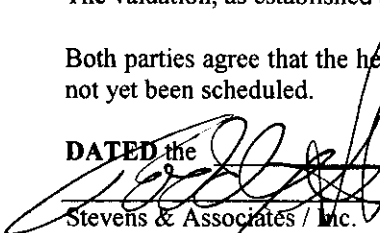

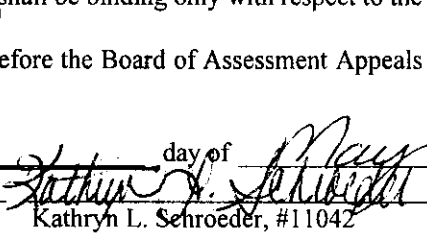

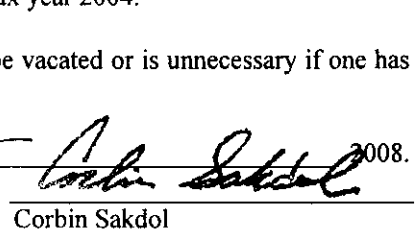
The valuation, as established above, shall be binding only with respect to the tax year 2004.
