Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as: LOT 5 HORSEBACK
2. The subject property currently is classified as Vacant.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2007:
