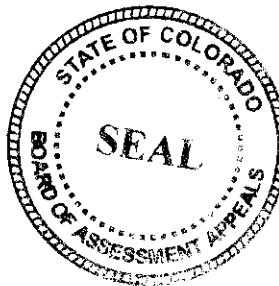


The valuation, as established above, shall be binding only with respect to the tax year 2007.

Both parties agree that the hearing before the Board of Assessment Appeals scheduled for February 28, 2008, at 8:30 a.m. be vacated.


