5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2007 actual value for the subject property:

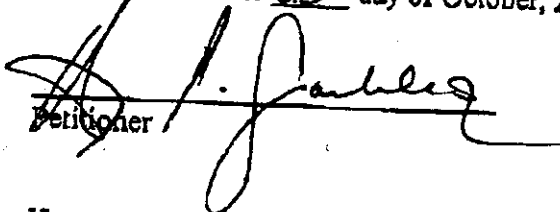

6. The valuation, as established above, shall be binding only with respect to tax year 2007.

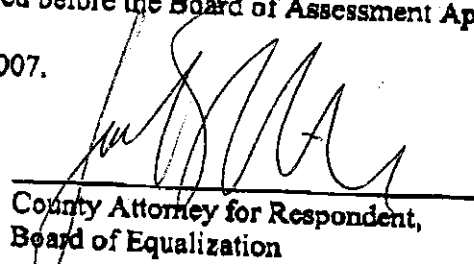
7. After reviewing sketches from the original property card and a recent appraisal, the Assessor verified that the correct square footage of the improvements is 2,388 square feet.
