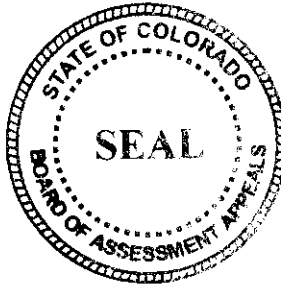

6. The valuation, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made: Reduced to market value based on the adjustment to rental data.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 11, 2008 at 3:00 p.m. be vacated.


