3. The parties agree that the 2007 actual values of the subject property shall be Stipulated Values below:



6. This valuation is for purposes of settlement only and does not reflect an appraised value.
7. Petitioner(s) agree(s) to waive his right to a Board of Assessment Appeals hearing and any further appeal of schedule number: **200268** for the assessment years(s) covered by this Stipulation.
