STIPULATION (AS TO TAX YEAR 2007 ACTUAL VALUE)	

Petitioner, ROBERT O. & MARTHA S. KLOTZ, and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax year 2007 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
 785 S. Alton Way #7A
 Denver, Colorado 80247
2. The subject property is classified as residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

Land	\$	17,400.00
Improvements	\$	<u>174,600.00</u>
Total	\$	192,000.00

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Land	\$	17,400.00
Improvements	\$	<u>162,100.00</u>
Total	\$	179,500.00

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

Land	\$	17,400.00
Improvements	\$	<u>149,600.00</u>
Total	\$	167,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

The original value was derived via mass appraisal techniques, with 233 sales in the complex. The value was then adjusted to the subject sale price in July of 2004. A revised value was then derived by using four comparables of the same model type, one of which was the subject sale, thus arriving at the recommended value

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 21, 2008 at 9:30 AM be vacated.
