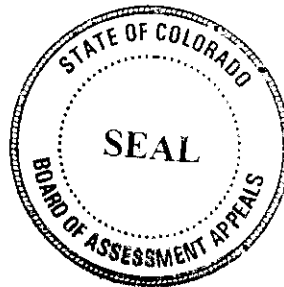

6. The valuations, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made

Per an interior inspection of the subject property and a review of comparable sales, a value of \$365,200 is recommended.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 4, 2008 at 8:30 AM be vacated.
