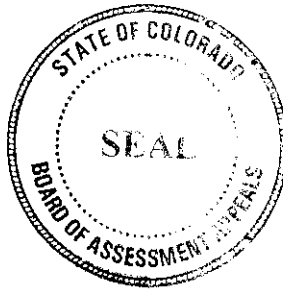

6. The valuations, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made:

Analysis of subject property's actual income and expense statement along with market sales of similar properties indicated a reduction in value is appropriate.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 21, 2008 at 1:00 PM be vacated.
