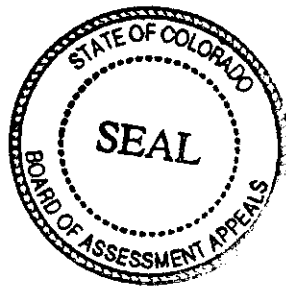

7. This valuation is for purposes of settlement only and does not reflect an appraised value.
8. ~~Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of schedule number: 437196, 434571, and 434569 for the assessment years(s) covered by this Stipulation.~~ *Except as set forth in Section 4 above,*
