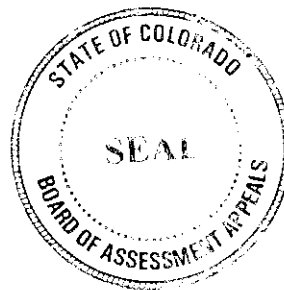

6. The valuations, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made:

Subject property suffers from deferred maintenance 10% adjustment resulted in reduction.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 23, 2009 at 8:30 AM be vacated.
