3. The County Assessor originally assigned the following actual value on the subject property for tax year 2007.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2007.

Total	\$	535,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

The Assessor conducted a review and found two comparable sales near the subject property resulting in a reduction in value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 27, 2009 at 8:30 AM be vacated.
