6. The valuations, as established above, shall be binding only with respect to tax year 2007.



Recognition of the most recent lease terms in place on the subject property.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 27, 2009 at 3 PM be vacated.
