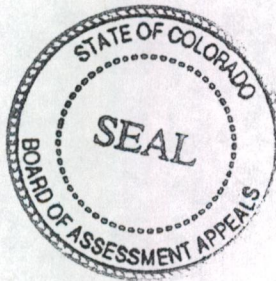




8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 15, 2009 at 8:30 AM be vacated.
