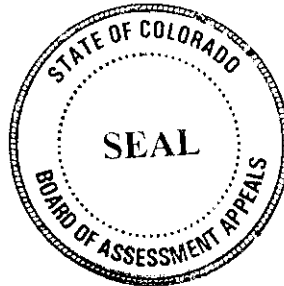

3. The County Assessor assigned the following actual value to the subject property for tax year 2007:


