7. Brief narrative as to why the reduction was made:


Review of area sales activity revealed the subject property is currently listed for sale \$750,000. This list price will be assigned for 2007; there is no appeal on record for 2008.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 23, 2009 at 10:30 AM be vacated.
