**Total Value:            \$5,220,000**

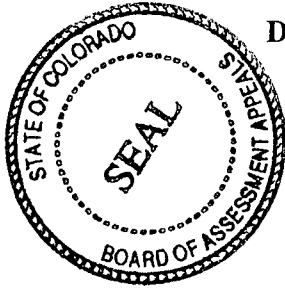




