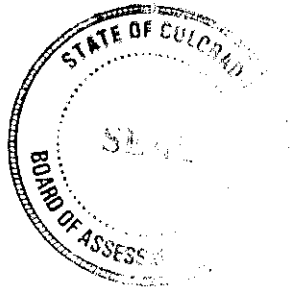


8. Both parties agree that each party shall be responsible for its own costs and attorney fees associated with this matter.
