2007 & 2008 dockets were consolidated by the Board of Assessment Appeals. Upon review of available comparable sales, the assessor determined a more appropriate value of \$80,000 per unit was applicable. Subject contains 26 apartment units (26 x \$80,000 = \$2,080,000).
