6. The valuations, as established above, shall be binding only with respect to tax year 2007.

7. Brief narrative as to why the reduction was made:

Commercial supervisor Larry George and tax agent Todd Stevens have decided on a reasonable estimate of value considering overall condition, location and factors that affect marketability of this property.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
