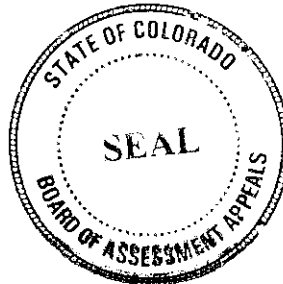

Subject property is classified as COMMERCIAL and described as follows: 4000-4102 S. Parker Rd, County Schedule Number 2073-06-3-64-001-007.






The valuation, as established above, shall be binding only with respect to the tax year 2008.
