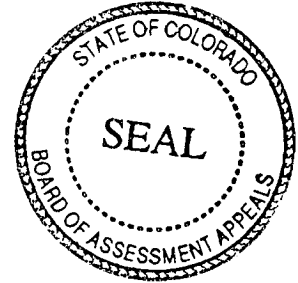

6. The valuations, as established above, shall be binding only with respect to tax year 2008.
