6. The valuations, as established above, shall be binding only with respect to tax year 2008.


7. Brief narrative as to why the reduction was made:

This adjustment considers the sale of the property prior to the base period.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 5, 2009 at 8:30 AM be vacated.
