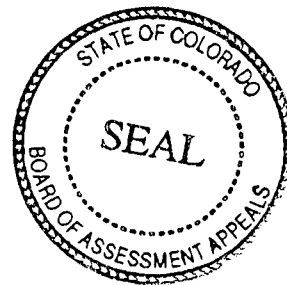

After further review of market sales and actual income and expense data, the assessor's office and the petitioner's tax agency agreed to a slightly lower overall value.


