3. The parties agreed that the 2008 actual value of the subject property should be reduced to:  
  

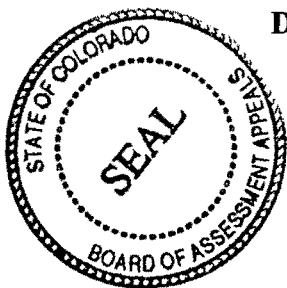
