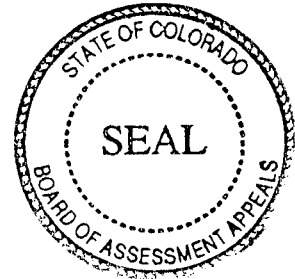

Further analysis of the make-up of the subject's revenue and the other approaches to value.


