3. The parties agreed that the 2008 actual value of the subject property should be reduced to:

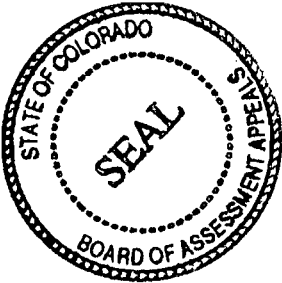

A further review of appropriate market information resulted in a reduced value estimate.


