3. The parties agreed that the 2007 actual value of the subject property should be reduced to:

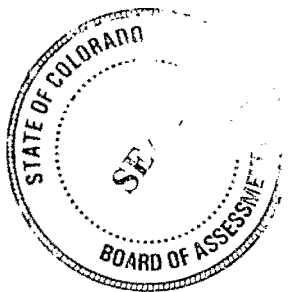

6. The valuation, as established above, shall be binding only with respect to tax year 2007.


7. Brief narrative as to why the reduction was made: Reduction to market value due to age (cost approach) and market.


