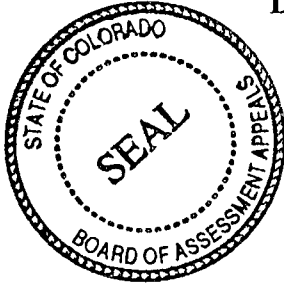
4. The Board concurs with the Stipulation.


The personal property in question is located in Teller and Gilpin counties.


