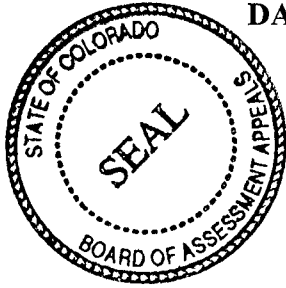
4. The Board concurs with the Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

Residential Condominium: \$ 1,778,500


4. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2009 actual value for the subject property:


Residential Condominium: \$ 1,450,000
