Total Value: \$425,000

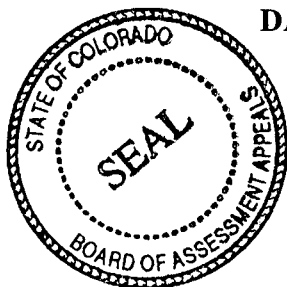
