Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as: Dawson Square Apartments, 8710 Dawson St., Thornton, CO.
2. The subject property is classified as Residential property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2009:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:
