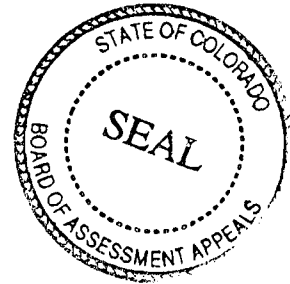

Total	\$	190,000.00


6. Brief narrative as to why the reduction was made:
