Petitioner, Michael and Kristin Mac Dermott, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as Mountain Valley Subdivision, Block 1, Lot 24, and is identified as Parcel No. 2737 172 07 074 in Pitkin County Assessor's Office records.
2. The County Assessor originally assigned the following actual value on the subject property for the tax year 2009:

Residential Land:	\$ 2,500,000
Residential Improvements:	<u>\$ 4,385,500</u>
<b>Total:</b>	<b>\$ 6,885,500</b>

3. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Residential Land:	\$ 2,500,000
Residential Improvements:	<u>\$ 3,500,000</u>
<b>Total:</b>	<b>\$ 6,000,000</b>

4. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2009 actual value for the subject property:

Residential Land:	\$ 2,500,000
Residential Improvements:	<u>\$ 3,300,000</u>
<b>Total:</b>	<b>\$ 5,800,000</b>


5. The valuation, as established above, shall be binding with respect to tax year 2009 and 2010.


