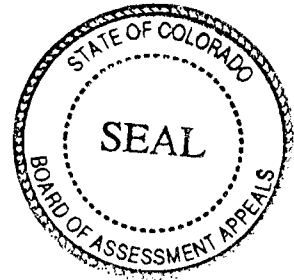

Petitioner, DAVID A. BIDDLE, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2009 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
 7861 East 29th Avenue
 Denver, Colorado 80238
2. The subject property is classified as Residential Row House.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

Improvements	\$	<u>416,100.00</u>
Total	\$	514,000.00

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

Improvements	\$	<u>445,800.00</u>
Total	\$	498,700.00

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2009.

Land	\$	52,900.00
Improvements	\$	<u>430,800.00</u>
Total	\$	483,700.00

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

I am also disputing the 2010 value and have requested the 2009 value also be applied to 2010.

7. Brief narrative as to why the reduction was made:

After reviewing the all the base period complex sales and taking into consideration that two homes on the subject's block were missing site/view CAMA entries and thus adjusting downward. It was reasonable to adjust the subject to the median valuation of like homes on the subject block.
