3. The County Assessor originally assigned the following actual value to the subject property for tax year 2009:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After review and negotiation, Petitioners and County Board of Equalization agree to the following tax year 2009 actual value for the subject property:

6. Brief narrative as to why the reduction was made:
